How much did SolarCity pay for TCPA violations?

SolarCity paid \$15 million in 2018 to resolve similar TCPA claims. More recently, in February 2020, consumers filed a class action against Sunlight Solar based on allegations of similar TCPA violations. Such allegations may not only subject companies to consumer class actions, but also fall within the purview of the Federal Trade Commission.

Does a PPA exempt affiliate and successor in interest equity transfers?

In addition, the PPA will typically exempt certain affiliate and successor in interest equity transfers provided the transferee agrees to be bound by the terms of the agreement and the project remains operated by a qualified operator.
